



RESIDENTIAL/HOUSING SUPPORTS AND SERVICES

Residential/Housing Supports and Services are an array of services designed for individuals to live in the community. Options include residential supports and services whereas the service provider is the landlord. Housing supports and services is an arrangement whereas the service provider is not the landlord of where the individual resides.

The array of supports varies for individuals and their living arrangement. Some individuals may receive drop-in support, daily support or 24-hour supports. Supports and services available may include, but are not limited to: personal assistance, health assistance, daily living skills, financial assistance, benefits management assistance, community access, recreational/leisure supports, educational/legal supports and/or transportation. Supports and services may be available through the service provider or individuals may access generic supports and services.

Drop in support or daily support is typically for individuals that reside on their own, with roommates and/or with family. The intensity and degree of supports is based on individual preferences and needs.

Twenty-four hour supports are typically for individuals with a higher level of needs. Their intensity and degree of supports is based on one's preferences and needs.

For most housing/residential supports, availability is based on eligibility for Medicaid services and/or other qualifications for specific residential/housing options.
